

STATEMENT, EXEMPTION, PROTECTION, DISCLAIMER.

Participation in a character of a driver/passenger/media.

Deciding to participate as a driver/passenger/media during a car event from 22 till 23.07.2023 in the area of Autodrom Jastrzb in Poland, I confirm that I am over 18 years old and in a proper physical condition to participate in the event.

Additionally, I declare that I am fully aware of all the risks and threats regarding the participation and that I am participating only in my own responsibility. Deciding to train with a passenger, I commit to inform him about the prevailing rules of Autodrom Jastrzb.

I understand that driving the car on the track unconditionally requires the use of a helmet for the driver and all the passengers, seat belts must be fastened, and the car must be equipped with an efficient fire extinguisher. I understand that during the training, while being on the track-exiting the car is heavily restricted. Damaged body kit parts will be collected by service staff and safely transported to the pits.

Every entrance to the track unconditionally requires the use of high visibility vest provided by the staff and the consent of the event organizer.

Therefore, I release, guarantee innocence and protect the organizers ("Protected Parties") from any claims, demands, actions, commitments, costs and expenses (and sums that they can ever pay as part of a settlement or compromise against such claims or monetary obligations) which may I or any other person death or in the event of injury (including a nervous shock) or any other person and any loss or damage to property arising in any way arising directly or indirectly from my participation or in connection with my participation as a passenger in the car during the ride described in this document. This obligation will be binding on my property, heirs, immediate family, executors, administrators, and other personal representatives.

I understand that my acceptance of participation described in this document refers only to the date proposed above.

I allow to publish and use my photographs, visual images, sound recordings and/or interviews with my participation or image of Autodrom Jastrzb in any way and at any time around the world without any money obligations to me.

I understand that it is absolutely forbidden to drive vehicles onto the sliding plate surface and any damage resulting from not adapting to the injunction I undertake to cover on my own. I also undertake to cover any other permanent damages on Autodrom Jastrzb objects caused intentionally or unintentionally.

I understand that during the event there is a total prohibition on driving a car or moving around the track under the influence of alcohol or any other intoxicants. I also agree with the fact that alcohol and intoxicants are forbidden for all the passengers.

In case of a driver being under 18 years old, the written consent of the legal guardian is required for driving a car on the track.

I declare that I have read the regulations of Autodrom Jastrzb and got acknowledged with it.

CONSENT ON PROCESSING OF PERSONAL DATA

I agree with the processing of my personal data by PTSLR Sp. z o.o. accommodated in Warsaw, ul. Terespolska 4/375 in order to accept the application of participation in the event and keeping the safety during the event in accordance with the Data Protection Act from 29th of August 1997 (Dz. U. DzU. 1997 nr 133 poz. 883) and with the Regulation of the European Parliament and the Council of European Union 2016/679 from 27th of April 2016 regarding the protection of physical persons in relation with processing of personal data and in case of free data flow and repeal of the directive 95/46/WE (RODO).

Data will be processed for 180 days. Expressing consent is voluntary. I am aware that I have access to my personal data in order to rectify them or delete and request to limit their processing due to my particular situation and withdrawal the consent in any moment, wherein, withdrawal of the consent will not affect the legality of processing the data before the withdrawal.

I also understand that I have a right to file a claim to the Personal Data Protection Office.
